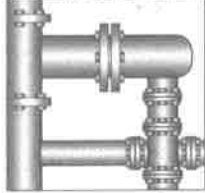

**SUMMARY ANNUAL REPORT FOR  
CONNECTICUT PIPE TRADES HEALTH FUND**

This is the Summary Annual Report for the Connecticut Pipe Trades Health Fund (Employer Identification Number 06-0660430, a multiemployer welfare plan, Plan Number 501) for the period July 1, 2022, through June 30, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Connecticut Pipe Trades Health Fund has committed itself to pay all hospital, medical, prescription drug, weekly disability, vision, hearing, and dental claims incurred under the terms of the Plan.

**Insurance Information**

The Health Fund has insurance contracts with the Union Labor Life Insurance Company to pay stop loss claims incurred under the terms of the Plan, for which the total premiums paid for the 2023 calendar year policy period was \$986,541. The Plan also has an experience-rated dental and PPO contract with Anthem 2022, the Plans, Inc. for the policy period July 1, 2022, through June 30, 2023. The total retention charges paid for the policy period was \$516,744, and the total of all benefit claims paid under the experience-rated contract was \$23,937,161. The Plan also has a contract with Symetra for AD&D and life insurance coverage, for which it paid \$347,668 in premiums for the policy period July 1, 2022, through June 30, 2023.

**Basic Financial Statement**

The value of Plan assets, after subtracting liabilities of the Plan, was \$25,663,144 as of June 30, 2023, compared to \$28,415,103 as of July 1, 2022. During the year, the Plan experienced a net loss of (\$2,751,959) in its net assets. This loss includes unrealized appreciation or depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the Plan Year, the Plan had total income of \$33,004,535, including \$28,862,280 in employer contributions, \$3,136,731 in participant contributions, a net gain of \$155,821 from the sale of assets, and a net gain on investments of \$849,703. Plan expenses were \$35,756,494. These expenses include \$32,077,986 in benefits paid and incurred by participants and beneficiaries, \$1,491,006 paid to insurance carriers for the provision of benefits, \$43,213 in other benefit payments, and administrative expenses of \$2,144,289.

If you request a copy of the full annual report from the Plan Administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report, because these portions are furnished without charge.

Further, you also have the legally protected right to examine the annual report at the Fund Office, and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
