**SUMMARY ANNUAL REPORT FOR THE NEW ORLEANS EMPLOYERS - INTERNATIONAL
LONGSHOREMEN'S ASSOCIATION, AFL-CIO WELFARE PLAN**

This is a summary of the annual report for the New Employers - International Longshoremen's Association, AFL-CIO Welfare Plan (EIN 72-0570875; Plan No. 501) for October 1, 2010 to September 30, 2011. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

INSURANCE INFORMATION

The Board of Trustees of the New Orleans Employers - ILA, AFL-CIO Welfare Plan has committed itself to pay all dental, vision, and temporary disability income claims incurred under the terms of the Plan. Dental and vision benefits were terminated December 31, 2010.

The Plan has an insurance policy with Reliance Standard Life Insurance Company through December 31, 2010 and with Dearborn National Life Insurance Company effective January 1, 2011 covering group life and accidental death and dismemberment claims. The premiums paid to Reliance under both the Group Life and AD&D policies for the insurance policy year beginning January 1, 2010 and ending December 31, 2010 were \$524,925. The premiums paid to Dearborn National under the Group Life and AD&D policies for the period beginning January 1, 2011 to September 30, 2011 were \$420,530.

BASIC FINANCIAL STATEMENT

The value of Plan assets, after subtracting liabilities of the Plan was \$2,099,590 as of September 30, 2011, compared to \$2,485,133 as of October 1, 2010. During the Plan year the Plan experienced a decrease in its net assets of \$385,543. This decrease includes unrealized appreciation or depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of assets at the beginning of the year, or the cost of assets acquired during the year. During the Plan year, the Plan had total income of \$1,275,804 including employer contributions of \$114,277, a transfer from the NOE-ILA Royalty Escrow Account of \$1,157,875, realized gains of \$153 from the sale of assets, earnings from investments of \$3,495 and other income of \$4.

Total Plan expenses were \$1,661,347. These expenses included \$469,414 in administrative expenses and \$1,191,933 in benefits, costs incurred to provide benefits, and premiums paid or accrued. A total of 1,859 people were participants in or beneficiaries of the Plan at the end of the Plan year.

NON-MEDICARE ELIGIBLE RETIRED EMPLOYEES AND DEPENDENTS

This is a summary of the annual report for the New Employers - International Longshoremen's Association, AFL-CIO Welfare Plan (EIN 72-0570875; Plan No. 502) for October 1, 2010 to September 30, 2011. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

INSURANCE INFORMATION

The Board of Trustees of the New Orleans Employers - ILA, AFL-CIO Welfare Plan for Non-Medicare Eligible Retired Employees and Dependents has committed itself to pay all medical, prescription and mental health claims incurred under the terms of the Plan. The Plan has an administrative services agreement with Zenith Administrators to process and pay all medical claims and with Magellan Behavioral Health to pay all mental health claims.

The Plan receives monthly reimbursement payments from the MILA Health Care Trust Fund for the cost of the medical/mental health claims and third party administrative fees. The MILA Plan administers the prescription benefit claims through its third party administrator and pays directly for those claims.

BASIC FINANCIAL STATEMENT

The value of Plan assets, after subtracting liabilities of the Plan was \$(481,700) as of September 30, 2011, compared to \$-0- as of October 1, 2010. During the Plan year the Plan experienced a decrease in its net assets of \$481,700. During the Plan year, the Plan had total income of \$2,433,307 including retired employee contributions of \$194,340, a transfer from the NOE-ILA Royalty Escrow Account of \$52,125 and reimbursement payments from the MILA Plan of \$2,186,842.

Total Plan expenses were \$2,915,007. These expenses included \$73,297 in administrative expenses and \$2,841,700 in benefits and costs incurred to provide benefits. A total of 414 people were participants and beneficiaries, or dependents of the Plan at the end of the Plan year.
