CVS Caremark Coming Soon

The Board of Trustees is proud to announce that effective **January 1, 2025**, your new Pharmacy Benefit Manager will be **CVS Caremark**. There will be no change in your copayment amounts at this time.

You will be receiving an information packet, and prescription card directly from **CVS Caremark** around mid-December. Please look for this packet in the mail and review the contents enclosed.

Pharmacy Prescriptions

If you are currently receiving your prescriptions at the pharmacy, **you must present the new CVS Caremark card on/after January 1, 2025**. Your prescriptions will be rejected by OptumRX after December 31, 2024.

ANNUAL NOTICE

WOMEN'S HEALTH AND CANCER RIGHTS ACTS OF 1998

Under federal law, group health plans, insurers and HMO's that provide medical and surgical benefits in connection with a mastectomy must provide benefits for certain reconstructive surgery effective for the first Plan Year beginning on or after October 21, 1998. In the case of a participant or beneficiary who is receiving benefits under the Plan in connection with a mastectomy and who elects breast reconstruction, federal law requires coverage in a manner determined in consultation with the attending physician and the patient, for:

- Reconstruction of the breast on which the mastectomy was performed;
- Surgery and reconstruction of the other breast to produce a symmetrical appearance; and
- Prostheses and treatment of physical complications at all stages of the mastectomy, including lymphedemas.

This coverage is subject to the plan's annual deductibles, co-payments and co-insurance provisions that may be applicable, consistent with those established for other benefits under the Plan. These provisions are generally described in the plan's Summary Plan Description (SPD).

If you have any questions about the plan's coverage for mastectomies or reconstructive surgery, please contact the Fund office.

NOTICE OF PRIVACY PRACTICES REMINDER NOTIFICATION

The Mid Central Operating Engineers Health and Welfare Fund is required by law to take reasonable steps to ensure the privacy of your personally identifiable health information.

The law requires Mid Central Operating Engineers Health and Welfare Fund to remind members, every three years, that the Notice of Privacy Practices is available.

The Plan's Privacy Policy is listed in the new Summary Plan Description/ Plan Document, effective January 1, 2021. This is just a reminder for participants to review the Policy located on pages 42-43 of the Summary Plan Description/Plan Document.

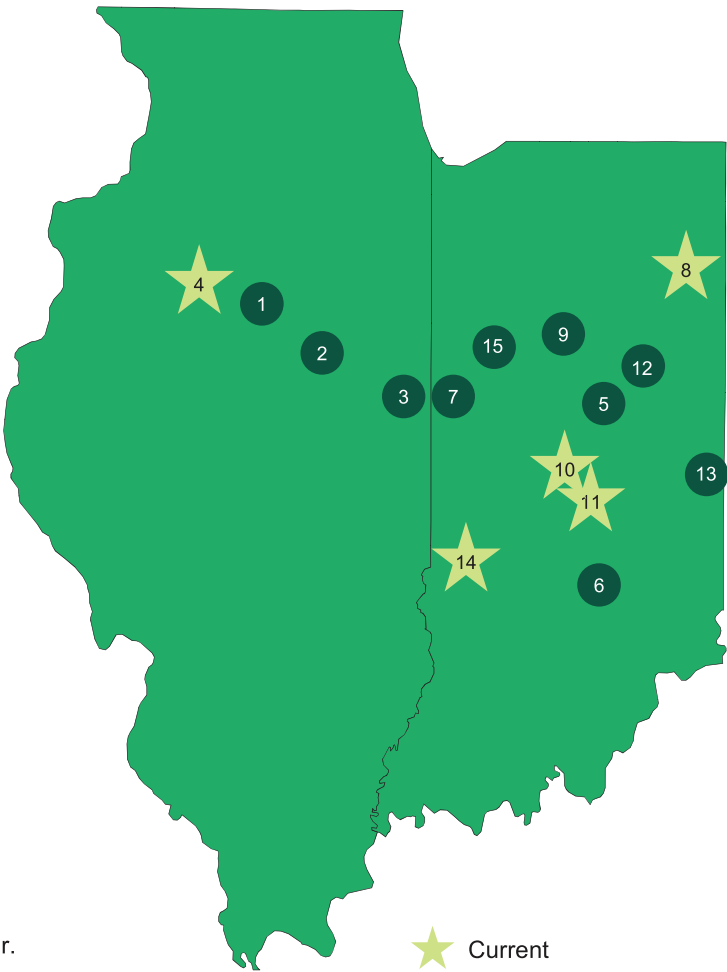
