This will officially serve to inform you that on <u>June 1st, 2019 a \$2.25 increase</u> will be effective in accordance with our **Three Year Contract Agreement**. At a Special Meeting of the membership on May 11, 2019 the members voted to allocate $\underline{\$1.25}$ in the category of <u>WAGES</u> and $\underline{\$1.00}$ in the category of <u>FRINGES</u>.

In the category of <u>FRINGES</u>, the members voted to allocate an additional <u>\$.60 to the PENSION FUND</u>, <u>\$.25 to the HEALTH & WELFARE</u>, and <u>\$.15 to the APPRENTICE FUND</u>. <u>WORKING DUES</u> will remain at 4.5% of the total package. The rates effective <u>June 1, 2019 to May 31, 2020</u> are as follows:

**NOTE: Working dues will now be deducted at \$3.50 per WORK hour with no adjustment for OVER TIME or DOUBLE TIME.

Dues deductions for Apprentice Plasterers shall be \$3.04 per hour.
