TO ALL EMPLOYERS OF CEMENT MASONS' UNION LOCAL NO. 502

This will officially serve to inform you that on <u>June 1, 2021 a \$2.51 increase</u> will be effective in accordance with our **Five-Year Contract Agreement**. At a Special Meeting of the Membership on May 8, 2021, the Membership voted to allocate <u>\$.50</u> in the category of <u>WAGES AND \$2.01</u> in the category of <u>FRINGES</u>.

In the category of FRINGES, the members voted to allocate an additional \$.51 to the PENSION, \$.80 to the HEALTH & WELFARE, \$.20 to the RETIREE WELFARE, and \$.50 to the ANNUITY FUND. WORKING DUES will remain at 4% of the total package. The rates effective June 1, 2021 to May 31, 2022 are as follows:

***NOTE: Working dues will now be deducted at \$3.45 per WORK hour with no adjustment for OVER TIME or DOUBLE TIME.

Please be advised that the SAVINGS FUND AND WORKING DUES are part of the Cement Masons' WAGES and are DEDUCTED after F.I.C.A., WITHHOLDING TAX, AND STATE TAX are withheld. Therefore, you will deduct §8.45 for straight time hours and §13.45 per hour for double time hours from the category of WAGES.

Rate of pay for work performed on **SATURDAY** shall be at time and one half (1-1/2). Therefore, **SAVINGS FUND AND WORKING DUES** deducted for work performed on **SATURDAYS** will be deducted at the rate of **\$10.95** per hour for **all hours worked on Saturdays**. **Permission** to work on Saturday, Sunday, and Holidays **must be obtained** from the Union Hall. At the Contractor's option the workday is from 7:00 A.M. to 11:00 A.M. and from 11:30 A.M. to 3:30 P.M. **OR** 8:00 A.M. to 12:00 Noon and from 12:30 P.M. to 4:30 P.M.

All active employers are now required to remit their monthly contributions online via ISSi-Remit, our online remittance processing system. Effective with your August 2021 work month contribution (due September 15, 2021), if you still opt to submit paper remittance reports, a 5% administrative fee will be assessed monthly on your total contribution. IMPORTANT NOTICE TO ALL CONTRACTORS Section 11, Paragraph 1 (a) of Current Agreement

For the purposes of reciprocity within the Northern Illinois District Council of the Operative Plasters' and Cement Masons' International Association consisting of Local Unions Nos. 502, 5, and the <u>areas 161</u>, <u>362</u>, <u>638</u>, of the <u>International Local No. 11</u>, there shall be a home local or area for each member.

The term "home local union" is defined as the local union or area in which an individual is a member in good standing or is dispatched from.

All authorized check-off, working dues, fringe benefits, training and savings funds shall be paid to the person's home local union in the same manner and in the same amounts as if the hours of work had been performed within the jurisdiction of the Cement Masons Home Local regardless of where the work was actually performed.

<u>Section 6, Paragraph 4: New Equipment.</u> Whenever a paving machine, concrete spreading machine, mechanical straight edge, multiple troweling machine, or similar type machine or any other new equipment or procedure is to be used on any type of work covered by this Agreement, which in the opinion of the Union could adversely affect the job security of employees covered by this Agreement, a **prejob conference** will be held. (This includes the **Laser Screed.**)
