ATTENTION "ACTIVE" PARTICIPANTS ON THE H&W FUND INSURANCE

Effective January 1, 2024, the Plumbers & Pipefitters Local 344 will transition from using the BCBS provider network to utilizing the <u>UnitedHealthcare Choice Plus Network</u> for provider selection. This new arrangement with UnitedHealthcare (UHC) is expected to generate savings for you and the Fund, all while improving access for you and your family to hospitals, clinics, surgeons etc. It is important to make sure that your current providers are in the new network.

In general, you should find this transition to the UnitedHealthcare Choice Plus network to be seamless as most providers in the previous BCBS network will also be found in this network, but you can start preparing now for this transition by visiting whyuhc.com/uhss.

• Find out if your primary physicians, specialists, and hospitals are in-network, simply navigate to whyuhc.com/UHSS – select:

- Find a doctor or facility
- Select the UnitedHealthcare Choice Plus network

• If the location that appears is not correct, click on change location. Enter a street address, city, and state, 5-digit zip code, or country. Update location.

• Select the type of medical care or enter a provider name or service and click Search. You will receive new ID cards late in December for the effective date of January 1, 2024. Use the new ID cards for any health care services you need after that date.
