### SUMMARY ANNUAL REPORT

# FOR IRON WORKERS DISCTRICT COUNCIL OF WESTERN NEW YORK AND VICINITY WELFARE FUND

This is a summary of the annual report for the Iron Workers District Council of Western New York and Vicinity Welfare Fund, EIN 16-0776208, Plan No. 501, for period July 1, 2010 through June 30, 2011. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Insurance Information**

The plan has a contract with a life insurance carrier to pay claims incurred under the terms of the Plan. Total premiums paid during the Plan year were \$11,272.

#### **Basic Financial Statement**

Benefits under the plan are provided through a trust fund. Plan expenses were \$ 3,592,553. These expenses included \$ 670,683 in administrative expenses (including \$ 7,499 of investment fees) and \$ 2,910,598 in benefits paid to participants and beneficiaries. A total of 335 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$ 1,678,609 as of June 30, 2011, compared to \$ 1,785,618 as of July 1, 2010. During the plan year, the plan experienced a decrease in its net assets by \$ 107,009. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$ 3,485,544, including employer contributions of \$ 2,781,622, participant contributions (self-pay) of \$ 529,261, realized gains of \$ 34,995 from the sale of investments, net earnings from investments of \$ 117,594, and other income of \$ 22,072.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report.
