SUMMARY ANNUAL REPORT

FOR IRON WORKERS DISCTRICT COUNCIL OF WESTERN NEW YORK AND VICINITY ANNUITY FUND

This is a summary of the annual report for the Iron Workers District Council of Western New York and Vicinity Annuity Fund, EIN 14-6195662, Plan No. 001, for period July 1, 2014 through June 30, 2015. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$1,930,191. These expenses included \$ 317,172 in administrative expenses and \$1,613,019 in benefits paid to participants and beneficiaries. A total of 1,169 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$31,992,549 as of June 30, 2015, compared to \$30,763,889 as of July 1, 2014. During the plan year, the plan experienced an increase in its net assets of \$1,228,660. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$3,158,851, including employer contributions of \$3,070,983, realized losses of (\$41,639) from the sale of investments, net earnings from investments of \$120,420, and other income of \$9,087.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

- 1. an accountant's report;
- 2. financial information and information on payments to service providers;
- 3. assets held for investment; and
- 4. transactions in excess of 5% of the plan assets.

To obtain a copy of the full annual report, or any part thereof, write or call the office of Iron Workers District Council of Western New York and Vicinity Annuity Fund, 3445 Winton Place, Suite 238, Rochester, New York 14623. The charge to cover copying costs will be actual cost per page to the plan, exclusive of the items mentioned below. However, such cost will not exceed \$.25 per page.

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report.

You also have the legally protected right to examine the annual report at the main office of the plan (Iron Workers District Council of Western New York and Vicinity Annuity Fund, 3445 Winton Place, Suite 238, Rochester, New York 14623) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
