SUMMARY ANNUAL REPORT

This is a summary of the annual report for the Iron Workers District Council of Western New York and Vicinity Welfare Fund, EIN 16-0776208, Plan No. 501, for period July 1, 2017 through June 30, 2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The Plan has a contract with a life insurance carrier and to pay claims incurred under the terms of the Plan, as well as a stop-loss insurance carrier to reimburse the Plan for certain large claims. Total premiums paid during the Plan year were \$134,669.

Basic Financial Statement

The value of Plan assets, after subtracting liabilities of the Plan, was \$1,631,441 as of June 30, 2018, compared to \$861,155 as of July 1, 2017. During the plan year, the Plan experienced an increase in its net assets of \$770,286. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had total income of \$4,560,755, including employer contributions of \$4,031,920, participant contributions (self-pay insurance premiums) of \$208,255, realized gains of \$3,038 from the sale of investments, net earnings from investments of \$20,839, reimbursements from related funds for shared administrative expenses of \$285,038, and income from employer interest and liquidated damages of \$11,665.

Benefits under the plan are provided through a trust fund. Plan expenses were \$3,790,469. These expenses included \$1,104,582 in administrative expenses, \$2,685,887 in benefits paid directly to participants and beneficiaries and to insurance carriers for the provision of benefits. A total of 248 persons were participants in or beneficiaries of the plan at the end of the plan year.

3. assets held for investment;
4. transactions in excess of 5% of the plan assets; and
5. insurance information including sales commissions paid by insurance carriers.

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both.
