SUMMARY ANNUAL REPORT

Dear Participant:

This is a summary of the annual report for the Iron Workers District Council of Western New York and Vicinity Annuity Fund, EIN 14-6195662, Plan No. 001, for period July 1, 2016 through June 30, 2017. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses totaled \$1,715,098. These expenses include \$272,868 in administrative expenses and \$1,442,230 in benefits paid to participants and beneficiaries. A total of 1,195 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$37,922,409 as of June 30, 2017, compared to \$34,047,563 as of July 1, 2016. During the plan year, the plan experienced an increase in its net assets of \$3,874,846. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$5,589,944 including employer contributions of \$2,965,638, realized gains of \$728,008 from the sale of investments, net earnings from investments of \$1,881,864, receipts from employer interest and liquidated damages of \$13,174 and miscellaneous income of \$1,260.
