Introduction

The Board of Trustees of the Iron Workers District Council of Western New York and Vicinity Welfare Fund (the "Fund") hopes that you and your families are staying safe and healthy during this national emergency. By now, everyone has heard of the "Coronavirus" or the illness it causes, known as "COVID-19." The Fund provides a wide range of benefits including but not limited to coverage for office visits, hospitalization, and diagnostic testing (including testing for COVID-19) to eligible participants. As always, we encourage you to use a PPO Provider to receive the highest level of benefits.

This notice describes important changes to the Iron Workers District Council of Western New York and Vicinity Welfare Fund.

Waiver of Cost Sharing for Treatment of COVID-19

Effective for services received on or after April 17, 2020 through September 7, 2020, if you receive treatment for COVID-19, the Fund will cover all services at 100% with *no cost-sharing by you*. This means the Fund will waive coinsurance for inpatient admissions, observation care, skilled nursing, ambulance, home care, or any claim for otherwise-covered service that is filed with a diagnosis of confirmed COVID-19. This does not include pharmacy benefits. These benefits will be covered at 100% of the allowed amount in accordance with the plan terms.

Telemedicine Benefit

As a reminder, the Fund offers telemedicine benefits through Excellus known as MDLive. MDLive is a telephone and online-based physician consultation service available 24 hours a day, 365 days a year. It is a convenient and affordable option that allows you to talk to a doctor who can diagnose, recommend treatment and prescribe medication, when appropriate, for many common medical issues.

Telehealth visits are a convenient way for you and your covered dependents to access care. The service gives you quick and easy access to a doctor wherever you are. You can talk to a physician without leaving your house. In fact, it is recommended that members use telehealth when possible to help prevent the spread of infection and improve access to care. It is a safe and effective way to receive medical guidance for many medical issues, including those related to COVID-19, from your home using your telephone or online (depending on your doctor).

While MDLive physicians are licensed in NYS, they cannot prescribe prescriptions such as controlled substances. However, they are able to provide general prescription services to your local pharmacy for medical conditions such as cold and flu symptoms, bronchitis, allergies, sinus problems, ear infections, and respiratory infections, to name a few.

When you use MDLive, you will only have to pay a \$10 copayment per consultation In-Network and it is not subject to your deductible.

Other telephonic visits, other than MDLive, will be covered consistent with office visits in accordance with the Plan terms.
