

# **Iron Workers District Council of Western New York and Vicinity Annuity Fund**

## **SUMMARY ANNUAL REPORT**

This is a summary of the annual report for the Iron Workers District Council of Western New York and Vicinity Annuity Fund, EIN 14-6195662, Plan No. 001, for period July 1, 2021 through June 30, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Basic Financial Statement**

Benefits under the plan are provided through a trust fund. Plan expenses totaled \$3,544,159. These expenses include \$3,186,805 in benefits paid to participants and beneficiaries and \$357,354 in administrative expenses. A total of 1,385 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$46,091,340 as of June 30, 2022, compared to \$50,930,221 as of July 1, 2021. During the plan year, the plan experienced a decrease in its net assets of (\$4,838,881). This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income (loss) of (\$1,294,722) including employer contributions of \$3,448,340, realized gains of \$37,080 from the sale of investments, net loss from investments of (\$4,795,145) and other income of \$15,003.

4. transactions in excess of 5% of the plan assets; and
5. information regarding any common or collective trusts, pooled separate accounts, master trusts, or 103-12 investment entities in which the Plan participates.

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report.

You also have the legally protected right to examine the annual report at the main office of the plan (Iron Workers District Council of Western New York and Vicinity Annuity Fund, 3445 Winton Place, Suite 238, Rochester, New York 14623) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
