

# **Iron Workers District Council of Western New York and Vicinity Supplemental Benefit Plan (Active Participants)**

## **SUMMARY ANNUAL REPORT**

This is a summary of the annual report for the Iron Workers District Council of Western New York and Vicinity Supplemental Benefit Plan (Active Participants) (the "Plan"), EIN 16-1550492, Plan No. 501, for the period July 1, 2020, through June 30, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Basic Financial Statement**

The value of Plan assets, after subtracting liabilities of the plan, was \$6,942,996 as of June 30, 2021, compared to \$6,196,788 as of July 1, 2020. During the plan year, the plan experienced an increase in its net assets of \$746,208. This increase includes net income from Plan operations of \$1,680,577, reduced by transfers of net assets to the Iron Workers District Council of Western New York and Vicinity Retiree Supplemental Benefit Plan (the "Retiree Plan") in the amount of \$934,369. Transfers to the Retiree Plan were to fund the account balance of new retirees. Plan net income includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had a total income of \$2,274,807, including employer contributions of \$449,822, realized gains of \$413,163 from the sale of investments, earnings from investments of \$1,405,848, and miscellaneous income of \$5,974.

Plan expenses for the fiscal year totaled \$594,230. These expenses include \$181,646 in administrative expenses and \$412,584 in benefits paid to participants and beneficiaries. A total of 521 persons were participants in the Plan, which includes beneficiaries.

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the

full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
