SUMMARY ANNUAL REPORT

This is a summary of the annual report for the Iron Workers District Council of Western New York and Vicinity Welfare Fund, EIN 16-0776208, Plan No. 501, for the period July 1, 2020, through June 30, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The Plan has a contract with a life insurance carrier to pay claims incurred under the terms of the Plan, as well as a stop-loss insurance carrier to reimburse the Plan for certain large claims. Total premiums paid during the Plan year were \$158,692.

Basic Financial Statement

The value of Plan assets, after subtracting liabilities of the Plan, was \$3,798,017 as of June 30, 2021, compared to \$3,776,123 as of July 1, 2020. During the plan year, the Plan experienced an increase in its net assets of \$21,894. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had a total income of \$5,572,292, including employer contributions of \$4,722,931, participant contributions (self-pay insurance premiums) of \$221,621, realized gains of \$87,168 from the sale of investments, net earnings from investments of \$140,525, reimbursements from related funds for shared administrative expenses of \$303,338, Paycheck Protection Program grant of \$65,325, and interest and liquidated damages from employers of \$31,384.

Benefits under the plan are provided through a trust fund. Plan expenses were \$5,550,398. These expenses included \$1,242,880 in gross administrative expenses, \$4,148,826 in benefits paid directly to participants and beneficiaries, and \$158,692 to insurance carriers for the provision of benefits. A portion of the administrative expenses are offset by reimbursements from related benefit funds for shared administrative expenses noted above. A total of 297 persons were participants in or beneficiaries of the plan at the end of the plan year.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report.
