

# Iron Workers District Council of Western New York and Vicinity Supplemental Benefit Plan

## SUMMARY ANNUAL REPORT

April 25, 2018

Dear Participant:

This is a summary of the annual report for the Iron Workers District Council of Western New York and Vicinity Supplemental Benefit Plan (the Plan), EIN 16-1550492, Plan No. 501, for period July 1, 2016 through June 30, 2017. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$7,575,241 as of June 30, 2017, compared to \$7,323,180 as of July 1, 2016. During the plan year, the plan experienced an increase in its net assets of \$252,061 as a result of normal Plan operations. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$1,070,117, including employer contributions of \$450,905, realized gain of \$229,145 from the sale of investments, earnings from investments of \$383,220, and miscellaneous income of \$6,847.

Benefits under the plan are provided through a trust fund. Plan expenses totaled \$818,056. These expenses include \$156,426 in administrative expenses and \$661,630 in benefits paid to participants and beneficiaries. A total of 805 persons were participants in or beneficiaries of the Plan.

2. financial information and information on payments to service providers;
3. assets held for investment; and
4. transactions in excess of 5% of the plan assets.

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (Iron Workers District Council of Western New York and Vicinity Supplemental Benefit Plan, 3445 Winton Place, Suite 238, Rochester, New York 14623) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
