### SUMMARY ANNUAL REPORT

April 25, 2018

## Dear Participant:

This is a summary of the annual report for the Iron Workers District Council of Western New York and Vicinity Welfare Fund, EIN 16-0776208, Plan No. 501, for period July 1, 2016 through June 30, 2017. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Insurance Information**

The Plan has a contract with a life insurance carrier and to pay claims incurred under the terms of the Plan, as well as a stop-loss insurance carrier to reimburse the Plan for certain large claims. Total premiums paid during the Plan year were \$171,018.

#### **Basic Financial Statement**

The value of Plan assets, after subtracting liabilities of the Plan, was \$861,155 as of June 30, 2017, compared to \$1,205,212 as of July 1, 2016. During the plan year, the Plan experienced a decrease in its net assets of \$344,057. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had total income of \$4,636,247, including employer contributions of \$4,113,977, participant contributions (self-pay) of \$226,024, realized gain of \$7,454 from the sale of investments, net income from investments of \$20,881, reimbursements from related funds for shared administrative expenses of \$260,867, and income from employer interest and liquidated damages of \$7,044.

Benefits under the plan are provided through a trust fund. Plan expenses were \$4,980,304. These expenses included \$1,117,429 in administrative expenses and \$3,862,875 in benefits paid to participants and beneficiaries. A total of 275 persons were participants in or beneficiaries of the plan at the end of the plan year.

The charge to cover copying costs will be actual cost per page to the plan, exclusive of the items mentioned below. However, such cost will not exceed \$.25 per page.

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report.

You also have the legally protected right to examine the annual report at the main office of the plan (Iron Workers District Council of Western New York and Vicinity Welfare Fund, 3445 Winton Place, Suite 238, Rochester, New York 14623) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
